This informational report was prepared through the collaborative efforts of the Louisiana Department of Revenue, the Louisiana Uniform Local Sales Tax Board, and the Louisiana Sales and Use Tax Commission for Remote Sellers as set forth in Section 3 of Act 685 (RS22).

Our teams of tax administrators, collectors, and advisors submit this report to offer our independent review of Louisiana’s unique state and local sales tax system; our recap of several meetings with other states who share in their own unique sales tax systems; and the desired functionality for centralized sales tax processing in Louisiana.
