Louisiana Revised Statute 47:302(K)(5) allows vendors who qualify as a "dealer" in this state solely by virtue of engaging in regular or systematic solicitation of a consumer market in this state by the distribution of catalogs, periodicals, advertising fliers, or other advertising, or by means of print, radio, or television media, including but not limited to television shopping channels, by mail, telegraphy, telephone, computer database, cable, optic, microwave, or other communication system. A vendor who qualifies as a dealer in this state as provided in LA R.S. 47:301(4)(a)-(k) is prohibited from collecting the tax imposed under this Subsection in lieu of collecting the sales and use tax imposed by a political subdivision of this state which tax is remitted directly to the political subdivision.

**Note:** A signature is required on page 2 of this application. This information will be used by the Department to determine if you qualify to file Form R-1031, *Direct Marketer Sales Tax Return*. If it is determined that your company qualifies to file Form R-1031, *Direct Marketer Sales Tax Return*, the department will notify you in writing. If approved, the seller agrees to collect, report, and remit the Direct Marketer's Sales Tax at a rate of 8.45%. The collection and remittance of tax imposed under LA R.S. 47:302(K)(5) relieves the eligible seller and the purchaser from any additional state or local sales and use taxes on the transaction.
