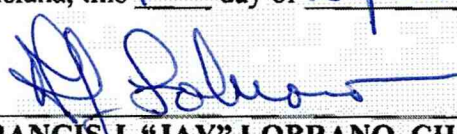
CONSENT JUDGMENT

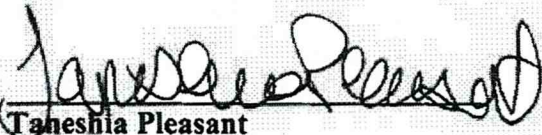
IT IS HEREBY ORDERED that Respondent, Taneshia Pleasant, is hereby immediately and permanently enjoined from directly or indirectly acting as a Louisiana tax return preparer, or filing, assisting in, or directing the preparation or filing of any Louisiana tax returns, amended returns, or other related documents or forms for any person or entity other than the Respondent's own personal tax returns.

IT IS FURTHER ORDERED that the Respondent, Taneshia Pleasant, is hereby imposed a penalty equal to twenty-five dollars for each of the unlawful returns filed by the Respondent after she was served with the Order to Cease and Desist, which penalty totals \$2,550.00, and is to be immediately paid by the Respondent to the Petitioner.

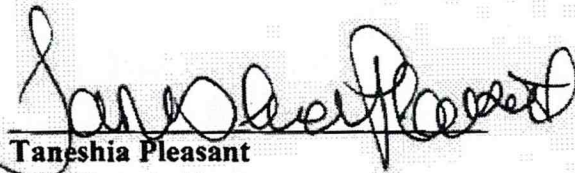
