JUDGMENT ON PRELIMINARY INJUNCTION

The Petitioner's *Motion for Preliminary Injunction* came before the Board on February 04, 2026. Presiding at the hearing were Francis J. Lobrano, Chairman, Judge Lisa Woodruff-White (ret.), Vice-Chair, and Michael G. Gaffney. Present before this Board was Daryl K. Causey, Jr., appearing for Jarrod J. Coniglio, Successor-Secretary, Department of Revenue, State of Louisiana. The Respondent, Deatrice Minor Garrison, a/k/a Deatrice Minor Seymore, a/k/a Deatrice Garrison Minor failed to appear for the hearing, despite being served with notice of the hearing.

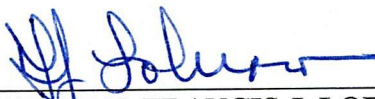
Considering the foregoing *Motion for Preliminary Injunction*, the memorandum of the Petitioner, the evidence submitted by the Petitioner, the arguments presented, and for reasons orally assigned on the record of the proceeding:

IT IS HEREBY ORDERED that the Petitioner's *Motion for Preliminary Injunction* is granted, and that the Respondent, Deatrice Minor Garrison, a/k/a Deatrice Minor Seymore, a/k/a Deatrice Garrison Minor, is, hereby, immediately enjoined from directly or indirectly acting as a Louisiana tax return preparer, and/or filing, assisting in, or directing the preparation or filing of any Louisiana tax return, amended returns, or other related documents or forms for any person or entity other than the Respondent's own person tax returns, until such time as a final decision has been rendered by this Board with respect to whether this injunction should be made permanent.

IT IS HEREBY ORDERED that the Respondent is cast with all costs of this proceeding, including the service costs of \$252.41,¹ which are associated with the initial service of *Motion for Preliminary Injunction*.

IT IS HEREBY ORDERED that the Respondent is cast with any and all future service costs associated with service of this *Judgment on Preliminary Injunction*.

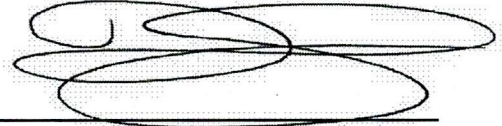
