Purchases of tangible personal property, digital products, and taxable services, and/or leases and rentals of tangible personal property and digital products by the political subdivision referenced below are totally exempt from the sales tax levied by the State of Louisiana as provided by La. R.S. 47:305.7(A)(1). The Louisiana Constitution, Article VI, §44(2) defines a political subdivision as "a parish, municipality, and any other unit of local government, including a school board and a special district, authorized by law to perform governmental functions." Political subdivisions making purchases from vendors requiring a certified exemption certificate may apply by completing Form R-1057. *Political Subdivision Certification*.
