

## Application for Sales Tax Exemption for Commercial Fishermen

NOTE: A separate application must be submitted for each vessel for which an exemption is requested.

This application must be accompanied by copies of a current vessel license issued by the Louisiana Department of Wildlife and Fisheries (LDWF), proof of vessel ownership, commercial fishing license, and a complete copy of the most current federal income tax return. Proof of vessel ownership may be a copy of the boat registration or a copy of the United States Coast Guard (U.S.C.G.) documentation. The vessel license, owner of vessel, fishing license, and federal income tax return must be in the same individual or corporation name.

I understand that exemption from state sales taxes is valid only as long as I am a commercial fisherman and meet all of the requirements for the exemption.

I understand that if I knowingly use this certificate for a purpose other than that authorized by La. R.S. 47:305.20, I may be subject to a fine of not less than \$100 per offense, but not more than \$1,000 per offense and imprisonment without hard labor for not less than one day, but not more than three months.

I understand that the exemption certificate issued by the Louisiana Department of Revenue may not be transferred to any other owner or person.
