The dealer must provide a copy of the Bill of Sale and a copy of the invoice along with a copy of the purchaser's out of state driver's license attached to each form. This form must be sent to the Louisiana Department of Revenue, Taxpayer Compliance Sales - Division, P.O. Box 66362, Baton Rouge, LA 70821-6362. A copy of this certificate along with a copy of the non-resident's driver's license must be retained by the seller for compliance purposes. Failure to comply will result in the seller being held responsible for the tax.
