or Rental Vehicles**

This form is for use by motor vehicle dealers who are seeking to apply for Form R-1310, *Purchases for Use by Qualified Vehicle Lessors Sales Tax Exemption Certificate*, which grants an exemption from state sales tax on vehicles purchased for lease or rental in accordance with La. R.S. 47:305(K)(3) and 47:305.36.

According to La. R.S. 47:305.36, the sales and use tax imposed by any taxing authority does not apply to the retail sale, purchase, lease, or importation of motor vehicles, trailers, or semitrailers, as defined in La. R.S. 47:451. This exemption applies only if these vehicles are stored, used, or consumed in the state exclusively for lease or rental. Additionally, the gross proceeds generated from leasing or renting such property, which has not been previously taxed, must be at reasonable market rates.

To qualify the following conditions must be met:

1. You must be registered to collect state sales tax.
2. Each separate location must have its own account number.
3. Each separate location must have its own license from the Motor Vehicle Commission or the Used Motor Vehicle Commission.
4. You must have a license issued by the Motor Vehicle Commission before the application for Form R-1310 can be approved.

Please note that licenses are issued by either the Louisiana Motor Vehicle Commission or the Louisiana Used Motor Vehicle Commission, and that LDR does not issue motor vehicle licenses.
